Munich 18 - 19 October, 2019

All CESifo research network members are invited to submit papers to the 2019 CESifo Area Conference on Energy and Climate Economics. The purpose of the conference is to bring together the members of the CESifo Research Network to present and discuss their ongoing research, and to stimulate interaction and cooperation between them. Submissions may deal with any topic within the field of Energy and Climate Economics.

SUBMISSION DETAILS

The deadline for submissions (complete papers or 2-3 page abstracts) is **14 July 2019 (midnight CEST)**. Preference will be given to complete papers. Please note that online submissions only will be accepted. Submissions may be completed using the following <u>link</u>. Alternatively you may go to the conferences page on our website, and click on the conference name, which will lead you to the submission page. Please note that the same paper is allowed to be submitted to only one of the CESifo Area Conferences. Authors of submitted papers will be notified no later than 2 August 2019 as to whether their paper has been accepted for the conference. Papers which are more related to the topic of other Area Conferences may be re-directed to the respective Area Director.

DISTINGUISHED CESIFO YOUNG AFFILIATE AWARD

The Distinguished CESifo Young Affiliate award, aimed at encouraging talented young scholars, will be awarded to the best paper presented by a young author at this conference. A maximum of four award candidates will be invited to attend the CESifo Area Conference and present their paper. An award committee will judge the papers (and presentations) and select a winner. Candidates will be accepted from close to completion of their PhD, to no more than five years after having completed it. The same limit applies to co-authors in the case of papers with multiple authors. The criteria for the award are scientific originality, policy relevance and quality of exposition. The winning paper will appear in the CESifo Working Paper Series and the prize winner will receive a €2000 prize.

All CESifo Research Fellows are welcome to nominate candidates for the award (please note that it is not mandatory for candidates to be from the research network). To nominate a candidate, a CESifo Research Fellow must submit the nominee's paper to Michael Hoel, University of Oslo (m.o.hoel@econ.uio.no), along with a brief letter explaining the motivation for the nomination. The deadline for nominations is 14 July 2019.

CONFERENCE DETAILS

CESifo will provide accommodation, and reimburse economy travel costs (in accordance with the CESifo Travel Policy) for CESifo Research Fellows/Affiliates with accepted papers. All papers presented at the conference will appear in the CESifo Working Paper Series. Other network members are invited to attend, but are expected to provide their own funding for travel and accommodation.
